#### **DEAR RESIDENT:**

The details of the proposed 2020-2021 school budget are included in this letter. The total budget of \$24,238,869 represents an overall increase of 3.23% with a tax levy of 2.99%. For a more detailed budget breakdown and return on investments, the latest edition of the Stakeholders Report can be located on the Moravia Central School District website in the upcoming days.

It has never been harder to craft a budget because there are still many unknowns. The proposed budget reflects an anticipated decrease in state aid. The good news is that all academic programs and extracurricular programs will be maintained. Also, this budget represents expanding student opportunities in the STEM disciplines district-wide and maintains our award-winning fine arts/ athletic programming. This budget proposal reflects an anticipated decrease in state aid, enhances programs, and remains responsible to our tax payers. We are exceptionally proud of this proposed budget and collectively feel that we have well positioned the district for the post COVID-19 challenges that lie ahead.

In addition to the budget there are two propositions for voter consideration. The first proposition is to purchase three 66-passenger school buses for an amount not to exceed \$362,000. The second proposition that is separate from the proposed school budget is the Powers Library Proposition that will be on the ballot.


18 years of age or older

Estimated Basic STAR Exemption Savings<sup>1</sup>

The annual budget vote for the fiscal year 2020-21 by the qualified voters of the Moravia school district, Cayuga County, New York, will be conducted in accordance with Executive Order 202.26, absentee ballots will be mailed by the District. At least one (1) absentee ballot will be provided per household. If a household requires additional absentee ballots, please contact the District Clerk at 315-497-2670, extension 2003 or email aburhans@moraviaschool.org. All ballots must be received by the District no later than June 9th, 2020 at 5:00 PM.

The basic school tax relief (STAR) exemption is authorized by section 425 of the Real Property Tax Law.
